Cabernet Sauvignon Mini-Tasting

Saturday, November 14, 2015 6:00 pm - 9:00 pm Various Host Sites

Our next Mini-Tasting theme is Cabernet Sauvignon. Cabernet Sauvignon is a favorite wine to accompany fine dinners, especially dinners featuring red meats.

Hosts: Mini-Tastings are held at various host sites around Orange County. If you would like to host this event, please email Bill Redding at bill@ocws.org or call him at 949.248.1125. You may need to sign up and pay until hosts are selected. Reimbursement will be made for all host sites.

Locations: Host sites and directions will be announced to those attending approximately one week prior to the event. We try to place you at the location nearest your home or to accommodate your specific site request; however, your assigned host site is also based on the order in which your sign-up is received in the OCWS office. The cost to attend the tasting is \$30 for members and \$35 for guests.

Dish: Each person attending brings a potluck dish (appetizer, entrée, side dish, or dessert) to serve a small portion to 18 people. The dish ideally should be designed to match the theme of the tasting, in this case Cabernet Sauvignon. Please coordinate your food selection with your host site to assure an appropriate balance of food types served during the evening. There will be a special bottle of wine that evening as a prize for Chef of the Evening. Our winning Chefs of the Evening may have their recipe published on the OCWS website. Please plan on arriv-



ing promptly at 6:00 pm so the event can start on time. You are invited to bring your own wine glasses for tasting. If bringing your own wine glasses, keep in mind the wines are served in flights of two.

We are planning a maximum of five sites for this minitasting, so the limit is 90 attendees. Due to the high attendance at our Mini-Tasting Programs, we encourage you to sign-up early as sites tend to fill quickly. The cut-off date for online sign-up is Monday, November 9. After this date please contact Bill or the OCWS office to determine availability. The cancellation deadline is November 6 for a refund. After that date, due to the advance purchase of wines, you will not receive a refund unless there is a waiting list.

New OCWS Office Hours & Parking Restrictions

New Office Hours



The OCWS office on the grounds of the OC Fair & Event Center (OCFEC) is now open Monday through Friday, 9 am to 2 pm.

Parking Restrictions

The following parking restrictions have been established by the OCEFC. We thank you in advance for your cooperation in following these guidelines at all times.



- 1. No parking directly in front of the OCWS office or next to the Courtyard at anytime.
- Parking is available on the Festival Asphalt area when no events are being held on the grounds utilizing the area.
- 3. If space is not available on the Festival Asphalt area, parking will be in either Lot F, next to the OC Fair administration building on Arlington Drive (access available 24 hours a day), or Lot B, outside of Centennial Farms off of Fair Drive (access available 7 am to 4

- pm). You will need to walk into the grounds from either of these locations.
- 4. Deliveries to, and loading/unloading of vehicles at, the OCWS office or The Courtyard are permissible at anytime for the length of time it takes to perform the task.

Centennial Farms, which is adjacent to the OCWS office, hosts children's educational programs continually throughout the year on both weekdays and weekends. These restrictions have been imposed by OCFEC for the safety of the children and staff. OCWS is bound by its agreement with OCFEC to adhere to their guidelines.

"I have so many fond memories of Mike, it is difficult to pick my favorite one. Several membership BBQs ago in 2006, Mike came up with the idea of making New Orleans Cray-

fish. We discussed it, and I suggested that we use shrimp rather than cray-fish because they would be more user-friendly to eat. Mike and I got the shrimp and mussels and he brought his pot and cooker and he prepared some of the best New Orleans style shellfish ever and they were the hit of the event. Mike also came up with the idea of serving deep fried items at our events and supervised their preparation. His creativity and innovative ideas greatly expanded our collective thinking on food items for all of our events.

Every night prior to the BBQ, Mike would come up to the house and help Barbara, me and other Cooks Caucus members chop vegetables, prepare other items for the event and, on occasion, we would work well into the night, and of course, enjoy wine and other assorted libations.

Mike was a great and creative cook, a hard worker and team player for the Cooks Caucus, and a great friend to all of us, and will be greatly missed by all who knew him. Traditional First Place – Bob & JaNae Unruh


Traditional Second Place – Dave & Pam Carter

History of the Orange County Wine Society

(Continued from page 1)

Brant Horton had always been disappointed with the entry criteria used by other wine competitions and wanted to conduct a judging of wines readily available in the Orange County marketplace. On May 24, 1976, during a meeting with Jerry Mead, a noted wine columnist, Brant proposed that the Orange County Fair would be an ideal host for a professional competition of Orange County marketplace wines made using only California grapes. On May 27, 1976, they met with the Orange County Fair's General Manager, Ken Fulk, and with the support of Warren Finley, President of the OC Fair Board of Directors, all agreed that a jointly-sponsored Commercial Wine and Homewine Competition would be held starting in 1977.

Brant Horton also recognized that a volunteer organization was needed to provide the staffing to conduct such events. At a meeting on July 23, 1976, at Brant's Wine Rack, he proposed an organization that would co-sponsor both Commercial and Homewine Competitions while also promoting the education and appreciation of wine, winemak-

ing, and viticulture. Brant Horton, Jerry Mead, and others went to work to form such an organization that was to be called the Orange County Wine Society. Eventually, Articles of Incorporation were drafted in January 1978 by Brant Horton and William Owen to form a nonprofit charitable and educational corporation under the laws of California including plans for a Wine Scholarship Fund. Fred Basom, Jim Graver, Brant and Kathi Horton, Jerry Mead, William Owen, and Mike Collins signed the initial articles. The articles called for the establishment of bylaws to guide the organization and its membership. The articles were subsequently registered with the California Secretary of State in June 1978 and the Internal Revenue Service approved a tax-exempt status for the OCWS under Section 501(c)(3) in 1980. The group met once a month on the second Friday. As the membership grew, it was proposed that a logo be designed for the OCWS. Dick Hamm won the design contest and it is the same logo used today. A competing logo, the "Purple Foot", was used to make stickers for distribution during the Fair. Early OCWS programs included wine tours at local wineries and food and wine tastings by Judi (Collins) Brady and Jane (McGrath) Goodnight.
